

## **Terms and Conditions of the international educational Project Global Atomic Quiz**

These Terms and Conditions determine the procedure and terms of the international educational Project “Global Atomic Quiz” (hereinafter referred to as the “Project”), including the rules of the participation in the Project and the winners selection process.

The Project’s goal is to increase public knowledge of nuclear physics; educate a wide international public about the latest world achievements in nuclear industry and the various benefits of the peaceful use of nuclear technologies.

The target audience of the Project (hereinafter referred to as the “Participants”): wide international audience, namely persons from any country in the world who meet the requirements and comply with the conditions provided for in these Terms and Conditions.

By participating in the Project, the Participants fully agree with these Terms and Conditions (hereinafter referred to as the “Terms and Conditions”).

The Project is governed by the Terms and Conditions. The Project is a non-profit outreach initiative; it is neither a promotion event nor a lottery.

### **General Information**

- 1.1. Title: international educational project “Global Atomic Quiz”.
- 1.2. Participants from any country in the world are eligible to participate in the Project.
- 1.3. The Project Organizer: the Autonomous Non-Profit Organization for the Development of Information Centers for Atomic Energy “Energy of the Future” (ANO Energy of the Future), TIN 7726385219, TRRC 772601001, address: 117105, Russian Federation, Moscow, Varshavskoe shosse, 3 (hereinafter referred to as the "Organizer").
- 1.4. Project duration:
  - 1.4.1. The total period for holding the Project is from November 10, 2023 to the date when the prizes are awarded to the winners, but not later than December 31, 2023. The total duration of the Project includes the period when the Participants take the actions required to participate in the Project; the time required for the Organizer to select the Project winners; and the time required for the Organizer to award the Prizes to the Winners based on the Project results.
  - 1.4.2. The period for holding the main part of the Project: Participants should take the quiz, which tests the knowledge of nuclear physics and nuclear technologies (hereinafter referred to as "the Quiz") at any time in the period from 00 hours 00 minutes 00 seconds on November 10, 2023 till 23 hours 59 minutes 29 seconds on November 10, 2023 (local time zone of the Participant).
  - 1.4.3. The period for summarizing the results and announcing the winners of the Project is until November 17, 2023 inclusive.
  - 1.4.4. The period for awarding Prizes to winners based on the results of participation in the Project in accordance with the Rules is from November 30, 2023 to December 31, 2023 inclusive.
  - 1.4.5. The exact dates for issuing the Prizes will be determined later, about which the Project Participants will be notified separately by the Organizer.
  - 1.4.6. The Organizer reserves the right to change the timeframes indicated in clauses 1.4.3. – 1.4.5. of the Terms and Conditions.
  - 1.4.7. If the awarding of the Prizes to the winners is impossible due to reasons beyond the Organizer's control (including, but not limited to, force majeure, natural disasters, decisions of local and/or federal authorities to impose quarantine measures, inability of a winner to attend the educational events), the Project Participants will be informed additionally. In this

case, the Organizer, at its discretion, has the right to cancel the transfer of the Prizes or change the timing of their issuance.

1.5. Ways of informing the Participants:

The Terms and Conditions, Project timeframes and results will be published on the Project's Website: [quiz.atomforyou.com](http://quiz.atomforyou.com), including all language versions (hereinafter referred to as the "Website").

1.6. Initial contact with the Participants and/or with their parents/legal representatives, which includes verification of data and identity documents, shall only take place from the Project's email address: [info@atomforyou.com](mailto:info@atomforyou.com).

## **2. Participants and Conditions of Participation in the Project**

2.1. Participants in the competitive part of the Project can be individuals from any country in the world who have filled out the registration form and agreed to the processing of personal data on the Project website. All other participants are free to participate in the Project without restrictions, but they will not be considered as part of the competition.

2.2. The Participants under the age of 18, who, due to the current legislation, cannot act independently under these Terms and Conditions, shall do so through their parents (or legal representatives) and/or with their assistance.

2.2.1. It is the responsibility of the minor Participants to inform their parents (legal representatives) of these Terms and Conditions, to obtain the necessary consents from their parents (legal representatives), including the consent to participate in the Project.

2.3. The following individuals should be excluded from the competition within the Project:

- employees of the Organizer; individuals representing the Organizer; their family members;
- third parties', employees and representatives, who have a contractual relationship with the Organizer and are associated with the Project, as well as their family members;
- employees and representatives of enterprises of the State Corporation «Rosatom».

2.4. The Project Participants have the right to receive information about the Project, in accordance with these Terms and Conditions;

2.5. The Project Participants shall have the following responsibilities:

- comply with the Terms and Conditions while participating in the Project;
- provide the Organizer with correct and truthful information in accordance with the Terms and Conditions;
- other responsibilities determined by these Terms and Conditions.

## **3. Project Participation Procedure. Project Winners Selection.**

3.1. The Winners will be determined based on the results of the competitive part of the Project, who, in accordance with the Project Terms and Conditions, will receive Prizes from the Organizer (hereinafter referred to as the Prizes).

3.2. To participate in the competitive part of the Project, the Participant must fill out the registration form on the Website.

3.2.1. Registration on the Website requires the applicants to provide the following information:

- First and last names;
- Date of birth;
- E-mail address;
- Country of residence;

- Mark of consent to participate in the Project and to the processing of personal data;
  - A note on the receipt of the consent of the parent / legal representative to participate in the Project and the consent of the parents / legal representatives to the processing of personal data for minor Participants.
- 3.2.2. The Organizer has the right to refuse participation in the competitive part of the Project to those Participants whose registration forms were not filled out properly (incomplete or incorrect information was entered). After registration, the Participant does not have the opportunity to change the e-mail address entered during registration on the Site.
- 3.3. The determination of winners occurs as follows:
- 3.3.1. Registered Participants must complete the tasks of the Quiz on the knowledge of the basics of nuclear physics and world achievements in the nuclear industry.
- 3.3.1.1. The Quiz takes place on the Internet on the Website [quiz.atomforyou.com](http://quiz.atomforyou.com), including all language versions.
- 3.3.1.2. The Quiz consists of 20 questions on nuclear topics of varying complexity, to which the Participant must answer by choosing the correct answer from those offered by the system.
- 3.3.1.3. The participant can answer the questions of the Quiz only once. Participants who have completed the Quiz multiple times will not be considered for the competition.
- 3.3.1.4. The participant can move on to the next question by answering the previous one.
- 3.3.1.5. The response time for each Quiz task will be tracked using a timer. The speed of completing all tasks will be taken into account in the Participant's final score when compiling the Winners rating.
- 3.3.1.6. Based on the number of correct answers and the speed of passing the Quiz, an automatic rating of the Winners is formed. The more points the Participant has received, the higher his position in the ranking will be.
- 3.3.2. The final score of the Participant is formed from the following components:
- 3.3.2.1. The number of correct answers in each rubric has a different weight: the rubric "True or False?" – 1 point for each correct answer; rubric "Your version" - 1 point for each correct answer; rubric "In order" - 1 point for one match, 2 points for two matches, 4 points for four matches.
- 3.3.2.2. Additionally, in calculating the final score of the Participant, the speed of completing the tasks of the Quiz is taken into account. A time factor is applied to each question, taking into account the speed of response to each question.
- 3.3.2.3. The higher the final score, the higher the place in the Participants' ranking.
- 3.3.2.4. In case of equality of points for several participants, the Participant who completed the Quiz faster is considered to have taken a higher place.
- 3.3.3. Approval of the Project Winners:
- 3.3.3.1 In order to ensure a more equitable geographical representation of the Winners, the Organizer will determine 100 Winners by 16 November 2023, based on the ranking of finalists and a country/region quota established by the Organizer. The quota for a country/region is determined by the Organizer upon completion of the Project proportionally to the total number of the Participants' countries or regions.
- 3.3.3.2 The Organizer, no later than within 6 (six) days after the expiration of the period specified in clause 1.4.2. of the Rules publishes on the Website of the Project a list of the Winners who scored the maximum number of points and took the first 100 places in the rating, by indicating the names of all Winners and their results. Winners will also receive e-mail notifications.
- 3.3.3.3 The Organizer contacts the Winners by e-mail to check for compliance with the requirements for Participants and compliance with their data specified during registration.

At the same time, the Organizer sends the Winners a request to send a valid address of residence (country, city, street, house, building, apartment, postal code) to the Project e-mail, as well as a contact phone number for organizing the receipt of Prizes.

- 3.3.3.4 If the Winner does not respond to the Organizer within 4 (four) days from the date of receipt of the notification and / or the Organizer has reasonable doubts about the conformity of the Participant's data specified during registration with real data, including, but not limited to, if the e-mail does not match specified during registration, or the Participant misrepresented personal data, registered under a fictitious and / or someone else's name, the Winner's Prize will be canceled, and the Organizer will have the right to select another Winner in accordance with the procedure described above.

## **4 Prizes for the Project Winners**

- 4.1 As a result of the Project, all Participants registered for participation in the Project will receive personalized electronic certificates from the Project Organizer. Participants who participated in the Project without registration will receive non-named electronic certificates.
- 4.2 No more than 100 Participants who have scored the maximum number of points can become the winners of the competitive part of the Project.
- 4.3 The gift set includes the following Prizes: a sweatshirt with atomic Velcro, five embroidered Velcro patches and a shopper bag.
- 4.3.1 Within 30 days after the expiration of the period specified in clause 1.4.2., the Organizer sends a letter to the Participant's e-mail address, in which he indicates the procedure for obtaining the Prize and the list of necessary information and documents for obtaining it.
- 4.3.2 Prizes will be delivered by post to the address provided by the Winner and/or by personal transfer. The Organizer has the right to determine the method of delivery of the Prizes in each case, of which the Winners will be notified as part of the receipt of the Prize.
- 4.3.3 In the case of postal items, the Organizer does not take responsibility for the delivery of the Prizes to the final recipient by the transport company. In case of loss of the parcel, the Participant is not entitled to demand any compensation related to participation in the Project.
- 4.4 The Organizer is not responsible for the payment of possible taxes and fees stipulated by the legislation of any foreign state in connection with the receipt of the Prize. All taxes and fees are the responsibility of the recipient of the Prize.

## **5. Final Provisions**

- 5.1. All disputes and disagreements that arise in connection with the organization and implementation of the Project are subject to resolution through negotiations. Disputable issues not settled through negotiations shall be resolved in court at the location of the Organizer in accordance with the substantive and procedural law of the Russian Federation.
- 5.2. Expenses for obtaining all documents provided by these Terms and Conditions, for performing all actions aimed at participating in the Project, the Participants, parents and / or legal representatives bear by themselves.
- 5.3. All handwritten documents must be legible. Scanned copies, photocopies must be fully legible, otherwise the Organizer has the right to consider them inappropriate.
- 5.4. If it is impossible to transfer the Prizes within the scheduled timeframe for reasons beyond the Organizer's control, the Organizer has the right to cancel or change the delivery time at its own discretion. In this case, the Participant shall not be entitled to claim any compensation related to participation in the Project.

5.5. The Organizer shall be entitled to engage third parties to carry out any activities within the Project's framework.
